EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-1111

Affirmed Overpayment

PROCEDURAL HISTORY: On July 27, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from June 10, 2018 through July 14, 2018. On August 16, 2018, that decision became final without a request for hearing having been filed. On August 28, 2018, the Department served notice of a decision assessing a \$2,365 overpayment based on the July 27, 2018 decision (decision #85454). On September 17, 2018, decision #85454 became final without a request for hearing having been filed. On September 26, 2018, claimant filed an untimely request for hearing on decision #85454. On November 20, 2018, ALJ S. Lee conducted a hearing, and on November 28, 2018 issued Order No. 18-UI-120399, allowing claimant's late request for hearing and affirming the Department's decision assessing an overpayment of \$2,365. On December 3, 2018, claimant filed an application for review with the Employment Appeals Board (EAB).

Based on a *de novo* review of the entire record in this case, and pursuant to ORS 657.275(2), the ALJ's findings and analysis with respect to the conclusion that claimant's late request for hearing should be allowed are **adopted**.

FINDINGS OF FACT: (1) On April 16, 2018, claimant filed an initial claim for unemployment insurance benefits. The benefit amount established was \$473.

- (2) Claimant claimed and was paid benefits for each week during the period from June 10, 2018 through July 14, 2018 (weeks 24-18 through 28-18).
- (3) Each week that claimant claimed benefits, she certified to the Department that she was actively seeking work. In total, claimant was paid \$2,365 in benefits for the weeks at issue.

CONCLUSIONS AND REASONS: Claimant is assessed a \$2,365 overpayment and is liable to repay that amount to the Department or to have it deducted from any future benefits otherwise payable to her.

ORS 657.155(1)(c) provides that an individual is eligible to receive benefits with respect to any week only if, among other things, claimant is actively seeking work during that week. ORS 657.310(1) provides that if an individual receives any benefits to which the individual is not entitled because the individual, regardless of the individual's knowledge or intent, made or caused to be made a false statement or misrepresentation of a material fact or failed to disclose a material facts, the individual is liable to repay the amount of those benefits to the Department or to have the amount of those benefits deducted from any future benefits otherwise payable to the individual.

Claimant did not dispute that she was paid a total of \$2,365 in benefits for the weeks at issue. Claimant also did not dispute that she certified to the Department that she was actively seeking work during each of the weeks at issue. The July 27, 2018 decision, which became final on August 16, 2018 and has not been vacated, modified or overturned as of the date of the hearing in this matter, establishes as a matter of law that claimant did not actively seek work during the weeks at issue, and that her certifications that she was actively seeking work were also false as matter of law. Consequently, even if claimant was not aware that she was making misrepresentations to receive benefits for the weeks at issue, ORS 657.310(1) still requires that she repay the \$2,365 in benefits that she received to which she was not entitled or to have \$2,365 deducted from any future benefits otherwise payable to her.

DECISION: Order No. 18-UI-120399 is affirmed.
