

**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-1118**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On September 19, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 74614). On October 9, 2018, decision # 74614 became final without claimant having filed a timely request for hearing. On November 6, 2018, claimant filed a late request for hearing. On November 9, 2018, ALJ Kangas issued Order No. 18-UI-119472, dismissing claimant's late request for hearing subject to claimant's right to review the request by responding to an appellant questionnaire by November 23, 2018. On November 29, 2018, Order No. 18-UI-119472 became final without claimant having responded to the questionnaire or filed an application for review with the Employment Appeals Board (EAB). On December 5, 2018, claimant responded to the appellant questionnaire and filed a late application for review with EAB. On December 5, 2018, ALJ Kangas issued a letter stating that claimant's response to the appellant questionnaire was untimely and would not be considered. This matter is before EAB pursuant to claimant's December 5, 2018 application for review.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On December 5, 2018, the appellant filed an application for review of Order No. 18-UI-119472 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than November 29, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-119472 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed December 5, 2018 is dismissed. Order No. 18-UI-119472 remains undisturbed.
