

**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-1119**

*Application for Review Dismissed Without Prejudice*

**PROCEDURAL HISTORY:** On October 17, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was denied benefits beginning September 23, 2018 because he failed to register for work as directed. On November 6, 2018, that decision became final without claimant having filed a timely request for hearing. On November 14, 2018, claimant filed a late request for hearing. On November 20, 2018, ALJ Kangas reviewed claimant's request and issued Order No. 18-UI-120002, dismissing claimant's late request for hearing subject to his right to renew the request by responding to an appellant questionnaire by December 4, 2018. On December 3, 2018, claimant responded to the questionnaire and filed an application for review of Order No. 18-UI-120002 with the Employment Appeals Board (EAB).<sup>1</sup>

ORS 657.275 provides that EAB shall review the record of the case promptly and affirm, modify, or set aside the decision of the ALJ if the Director of the Department or any interested party files a timely application for review. However, it appears that claimant has initiated further proceedings at the Office of Administrative Hearings (OAH) by returning an appellant questionnaire to OAH, and that this matter therefore is not yet ripe for review. We therefore dismiss claimant's application for review without prejudice to allow the proceedings at OAH to be completed.

If OAH does not issue a new order, claimant has the right to request that EAB review this matter based upon his December 3, 2018 application for review. If OAH issues a new order, claimant will have the right to appeal the new order to the Employment Appeals Board by filing a new application for review.

**DECISION:** The application for review filed December 3, 2018 is dismissed without prejudice. Order No. 18-UI-120002 remains undisturbed.

<sup>1</sup> On December 6, 2018, EAB sent claimant a letter stating that EAB would review his case. However, EAB sent that letter in error, because Department records show that he also filed a timely response to the appellant questionnaire attached to that hearing decision, and further proceedings at OAH are necessary. Therefore, EAB will not review this case at this time.
