# EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-1122

Affirmed
No Disqualification

**PROCEDURAL HISTORY:** On October 4, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision #80816). Claimant filed a timely request for hearing. On November 16, 2018, ALJ Janzen conducted a hearing, and on November 19, 2018, issued Order No. 18-UI-119947, concluding claimant voluntarily left work with good cause. On December 3, 2018, the employer filed an application for review with the Employment Appeals Board (EAB).

The employer submitted written argument to EAB with its application for review, and EAB considered the employer's written argument in reaching this decision. The employer asserted that claimant did not provide "documentation" of having been diagnosed with alcoholism or that his decision to quit work when he did was supported by a medical professional. However, claimant provided unrefuted testimony that he was first diagnosed with alcohol use disorder during the early 1990s. Audio Record at 21:08 to 24:44. Claimant also provided unrefuted testimony that his counselor agreed with his decision to voluntarily leave work with the employer to begin residential treatment for his alcohol use disorder. Audio Record at 31:13 to 31:58. Absent evidence to the contrary, or a basis for determining that claimant was not a credible witness, his testimony was sufficient to meet his burden of proof on those factual issues.

The employer also argued that claimant had reasonable alternatives to quitting work when he did because he could have taken medical leave or waited for a response from the employer regarding his pending application for a day shift. The record does not show that asking for family medical leave was a reasonable alternative for claimant because claimant's testimony showed that the requirements of the job were unhealthy for claimant, and those requirements and their impact on claimant's health would not have changed by taking a leave of absence to seek treatment. Those requirements included the work stress and the strain of unplanned overtime due to the employer's need to maintain its staff to client ratio. Moreover, even had the employer eventually given claimant a day shift, there was no evidence to show that he would no longer be subject to the same work stress and unplanned overtime requirements.

Claimant proved by a preponderance of the evidence that continuing to work for the employer and taking a leave of absence from work, was not a reasonable alternative for him.

On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

**DECISION:** Order No. 18-UI-119947 is affirmed.
