

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1130

Affirmed
Late Requests to Reopen Dismissed

PROCEDURAL HISTORY: On May 30, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from January 7 through March 24, 2018 (decision # 145710). On June 19, 2018, decision # 145710 became final without claimant having filed a request for hearing. On August 2, 2018, the Department served notice of an administrative decision, based on decision # 145710, concluding that claimant was overpaid \$3,608 in benefits that he must repay the Department (decision # 122945). On August 22, 2018, claimant filed a late request for hearing on decision # 145710 and a timely request for hearing on decision # 122945. On September 11, 2018, the Office of Administrative Hearings (OAH) served notice of hearings on decision # 145710 and decision # 122945 scheduled for September 27, 2018. On September 27, 2018, claimant failed to appear at the hearings, and ALJ Amesbury issued Order No. 18-UI-117330 and Order No. 18-UI-117343, dismissing claimant's requests for hearing due to his failure to appear. On October 17, 2018, Order No. 18-UI-117330 and Order No. 18-UI-117343 became final without claimant having filed requests to reopen the hearings. On November 13, 2018, claimant filed late requests to reopen the hearings. On November 28, 2018, ALJ Kangas issued Order No. 18-UI-120394 and Order No. 18-UI-120398 dismissing claimants requests as untimely without a showing of good cause. On December 7, 2018, claimant filed applications for review of Order No. 18-UI-120394 and Order No. 18-UI-120398 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 18-UI-120394 and 18-UI-120398. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-1129 and 2018-EAB-1130).

Claimant submitted written arguments with his applications for review. However, claimant's arguments contained information that was not part of the hearing record, and claimant failed to show that factors or circumstances beyond his reasonable control prevented him from offering the information into the hearing record when filing his requests to reopen the September 27, 2018 hearings, as required under OAR 471-040-0041(4) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (October 29, 2006), we considered only information received into the hearing record when reaching this decision.

EAB reviewed both hearing records in their entirety. On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Order No. 18-UI-120394 and Order No. 18-UI-120398 are affirmed.
