

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1136

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On October 9, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 84808). Claimant filed a timely request for hearing. On November 7, 2018, ALJ Buckley conducted a hearing, and on November 7, 2018 issued Order No. 18-UI-119354, concluding the employer discharged claimant but not for misconduct. On November 27, 2018, Order No. 18-UI-119354 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On November 29, 2018, the employer filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On November 29, 2018, the appellant filed an application for review of Order No. 18-UI-119354 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than November 27, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

In its application for review, the employer requested that a hearing be scheduled regarding claimant’s work separation. We note that the Office of Administrative Hearings already scheduled and held a hearing on the merits of the Department’s administrative decision # 84808, which the employer attended on November 7, 2018. The employer therefore is not entitled to another hearing. To any extent the employer’s letter was or might be construed as a request for relief of charges pursuant to the Department’s November 14, 2018 letter, EAB has referred that letter and associated documents to the Department, and the employer should contact the Department directly with any questions regarding such a request or other matters related to charges potentially resulting from this claim.

Order No. 18-UI-119354 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed November 29, 2018 is dismissed. Order No. 18-UI-119354 remains undisturbed.
