EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-1139

*Affirmed
Disqualification*

PROCEDURAL HISTORY: On October 18, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 113613). Claimant filed a timely request for hearing. On November 8, 2018, ALJ Wyatt conducted a hearing, and on November 16, 2018 issued Order No. 18-UI-119917, affirming the Department's decision. On December 6, 2018, claimant filed an application for review by the Employment Appeals Board (EAB).

Claimant submitted written argument with his application for review but failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we did not consider the argument when reaching this decision.

Even if we considered claimant's argument when reaching this decision, however, the outcome would remain the same. A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless he proves, by a preponderance of the evidence, that he had good cause for leaving work when he did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). Under OAR 471-030-0038(5)(a), if an individual leaves work to accept an offer of other work, good cause exists only if the offer is definite. EAB reviewed the entire hearing record, which supports the ALJ's determination that claimant quit working for the employer to accept an offer of other work that was not definite because it was contingent upon claimant passing a background check.¹ The record therefore supports the ALJ's conclusion that claimant quit working for the employer without good cause, and is disqualified from receiving benefits.²

On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-119917 is affirmed.
