

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1142

Affirmed
Disqualification

PROCEDURAL HISTORY: On October 22, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 121107). Claimant filed a timely request for hearing. On November 27, 2018, ALJ Frank conducted a hearing at which the employer failed to appear, and on November 28, 2018 issued Order No. 18-UI-120367, affirming the Department's decision. On December 13, 2018, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant's application for review included a written argument, but failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, EAB considered the entire record, but did not consider claimant's argument when reaching this decision. However, had EAB considered claimant's argument, the outcome would have been the same. In his argument, claimant asserted that his hearing was unfair because the ALJ interrupted claimant and claimant would lose focus during his testimony, and because he was offended that the ALJ asked him if he had "mental issues." We reviewed the hearing record in its entirety, particularly the ALJ's findings, conclusions and analysis contained in his order which shows that the ALJ inquired fully into all of the matters at issue and gave claimant a reasonable opportunity for a fair hearing as required by ORS 657.270(3) and OAR 471-040-0025(1) (January 11, 2018). After claimant testified about foot surgery, the ALJ asked claimant questions regarding potential long-term physical or mental impairments. Audio Record at 19:19 to 20:44. Questions regarding claimant's health were necessary for the ALJ to inquire into whether to apply a modified standard for good cause to leave work based on whether claimant had a permanent or long-term physical or mental health impairment.

On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-120367 is affirmed.
