EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1159

*Affirmed
No Disqualification*

PROCEDURAL HISTORY: On October 26, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 144345). Claimant filed a timely request for hearing. On November 21, 2018, ALJ S. Lee conducted a hearing, and on November 29, 2018, issued Order No. 18-UI-120459, concluding the employer discharged claimant, but not for misconduct. On December 18, 2018, the employer filed an application for review with the Employment Appeals Board (EAB).

The employer filed a written argument with EAB in which it questioned claimant's credibility regarding her testimony about the final incident on September 14, 2018 due to inconsistencies between her testimony and prior statements to the Department. Claimant's prior statements to the Department appeared inconsistent with her testimony at hearing regarding the reason she relied on a friend to drive her to work on September 14. However, the relevant testimony, regarding the reason claimant was late for work and her efforts to avoid being late for work, was consistent and undisputed in the record. Claimant's efforts to avoid being late for work show she was not indifferent to the consequences of being late, thus making her actions or inactions fall short of being willful or wantonly negligent. Moreover, claimant's prior attendance issues were due to illness or other circumstances and did not appear to be willful or wantonly negligent violations of the employer's attendance policy. Therefore, even if the final incident were a wantonly negligent violation of the employer's attendance policy, it would be an isolated instance of poor judgment.

EAB reviewed the entire record and the employer's written argument. On *de novo* review and pursuant to ORS 657.275(2), Order No. 18-UI-120459 is **adopted**.

DECISION: Order No. 18-UI-120459 is affirmed.
