

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1169

Applications for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On May 31, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 131406). On June 20, 2018, decision # 131406 became final without claimant having filed a request for hearing. On August 2, 2018, the Department served notice of an administrative decision, based on decision # 131406, concluding that claimant was overpaid \$1,720 in benefits that he must repay the Department (decisions # 123655). On August 22, 2018, decision # 123655 became final without claimant having filed a request for hearing. On October 12, 2018, claimant filed late requests for hearings on both administrative decisions. On October 17, 2018, ALJ Kangas issued Order No. 18-UI-118302 dismissing claimant's late request for hearing on decision # 131406 and Order No. 18-UI-118301 dismissing claimant's late request for hearing on decision # 123655, subject to claimant's right to renew the requests by responding to appellant questionnaires by October 31, 2018. On November 6, 2018, Order No. 18-UI-118302 and Order No. 18-UI-118301 became final without claimant having either responded to the questionnaires or filed timely applications for review of the orders. On December 14, 2018, claimant filed late responses to the appellant questionnaires and late applications for review of Order No. 18-UI-118302 and Order No. 18-UI-118301 with the Employment Appeals Board (EAB). On December 18, 2018, ALJ Kangas served notice that because claimant's responses to the appellant questionnaires were late, they would not be considered, and Order No. 18-UI-118302 and Order No. 18-UI-118301 therefore remained in effect. These matters are before EAB based on claimant's December 14, 2018 late applications for review.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders 18-UI-118302 and 18-UI-11301. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-1169 and 2018-EAB-1170).

CONCLUSIONS AND REASONS: The applications for review should be dismissed.

On December 14, 2018, the appellant filed untimely applications for review of Order No. 18-UI-118302 and Order No. 18-UI-11301 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than November 6, 2018. The

deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the applications were filed after the filing deadline expired. Accordingly, the applications for review are dismissed.

Order No. 18-UI-118302 and Order No. 18-UI-118301 remain undisturbed. EAB will take no further action with regard to these matters.

DECISION: The applications for review filed December 14, 2018 are dismissed. Order No. 18-UI-118302 and Order No. 18-UI-118301 remain undisturbed.
