EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-1174

Affirmed No Disqualification

PROCEDURAL HISTORY: On November 14, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 115223). Claimant filed a timely request for hearing. On November 28, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for December 12, 2018 to claimant and the employer. On December 12, 2018, ALJ S. Lee conducted a hearing, at which the employer failed to appear, and on December 13, 2018, issued Order No. 18-UI-121175, concluding the employer discharged claimant not for misconduct. On December 17, 2018, the employer filed an application for review with the Employment Appeals Board (EAB).

In written argument, the employer requested that the December 12, 2018 hearing be reopened and submitted new information regarding claimant's work separation for EAB's consideration. The employer's statement and request for relief is construed as a request to have EAB consider additional evidence under OAR 471-041-0090 (October 29, 2006), which allows EAB to consider new information if the party offering the information shows it was prevented by circumstances beyond its reasonable control from presenting the information at the hearing.

In support of its request, the employer asserted that it did not receive the notice of the December 12, 2018 hearing in a timely manner because OAH sent the notice of hearing to the offices of Grimstad and Associates rather than to the employer's administrative office, and Grimstad and Associates did not give the notice to the employer until after the hearing. Employer's Written Argument. The employer further asserted that Grimstad and Associates processes the employer's payroll and provides accounting services, but does not complete administrative duties related to the employer's employee work separations. *Id.* It was within the employer's reasonable control to provide the Department and OAH its preferred address for the purposes of processing unemployment insurance benefit matters. Moreover, the employer stated in its application for review that it received the administrative decision from the Department denying benefits, thus it was on notice that claimant might request a hearing at that time. The OAH mailed the notice of hearing to the employer's payroll service to give the notice to the employer. For these reasons, the employer's request for EAB to consider new information under OAR

471-041-0090 is denied. Accordingly, EAB considered the employer's argument regarding claimant's work separation only to the extent it was based on information received into evidence at the hearing.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Order No. 18-UI-121175 is affirmed.
