

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1176

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On October 5, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding, claimant was not available for work from August 19, 2018 to September 29, 2018 (decision # 130025). Claimant filed a timely request for hearing. On November 2, 2018, ALJ Scott conducted a hearing, and on November 6, 2018, issued Order No. 18-UI-119260, modifying decision # 130025, and concluding that claimant was not available for work from August 19, 2018 to September 15, 2018, and was available for work from September 16, 2018 to October 27, 2018. On November 26, 2018, Order No. 18-UI-119260 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 18, 2018, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On December 18, 2018, the appellant filed an application for review of Order No. 18-UI-119260 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than November 26, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-119260 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed December 18, 2018 is dismissed. Order No. 18-UI-119260 remains undisturbed.
