

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1186

Affirmed
No Disqualification

PROCEDURAL HISTORY: On November 1, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 110903). Claimant filed a timely request for hearing. On November 29, 2018, ALJ Scott conducted a hearing, and on December 4, 2018 issued Order No. 18-UI-120664, reversing the Department's decision. On December 20, 2018, employer filed an application for review with the Employment Appeals Board (EAB).

The employer submitted a written argument in which it contended that Order No. 18-UI-120664 was unsupported by the hearing record because it "focuse[d]" on a telephone call that claimant had with a transgender customer and not the incident that led to claimant's discharge, which was claimant's alleged behavior during a later interaction with a supervisor addressing claimant's treatment of the transgender customer during the call. However, although Order No. 18-UI-120664 included a finding of fact about the substance of claimant's call with the transgender customer, it plainly stated that claimant's behavior during the interaction that followed with her supervisor was the "incident that led directly to claimant's discharge," and proceeded to evaluate only that incident in determining whether the employer proved that it discharged claimant for misconduct. Order No. 18-UI-120664 at 1-2, 3-4. The ALJ evaluated the appropriate incident in reaching the conclusion that the employer did not show that claimant engaged in misconduct.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-120664 is affirmed.
