EMPLOYMENT APPEALS BOARD DECISION

2018-EAB-1196

Affirmed

Request to Reopen Denied

PROCEDURAL HISTORY: On October 29, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from September 30, 2018 to October 28, 2018 due to her refusal to accept employment which paid \$15.00 per hour (decision # 94824). Claimant filed a timely request for hearing. On November 20, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 7, 2018. On December 7, 2018, claimant failed to appear at the hearing, and ALJ Wyatt issued Order No. 18-UI-120930, dismissing claimant's request for hearing for failure to appear. Claimant filed a timely request to reopen the hearing. ALJ Kangas reviewed claimant's request, and on December 18, 2018 issued Order No. 18-UI-121403, denying the request. On December 28, 2018, claimant filed an application for review of Order No. 18-UI-121403 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. With her application for review, claimant submitted a written argument containing information regarding her availability for work, and in which she asserted that her failure to call in for the December 7, 2018 hearing at the scheduled time was "an honest mistake." However, the information regarding claimant's availability to work is not relevant to EAB's determination of the issue before us, whether claimant had good cause for failing to appear at the December 7, 2018 hearing. *See OAR 471-040-0090* (October 29, 2016). We therefore considered claimant's written argument to the extent that it was relevant to the issue before us. We agree with the ALJ that claimant's mistake was not an "excusable" mistake under OAR 471-040-0040(2) (February 10, 2012), because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-121403 is affirmed.
