

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0003

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On October 1, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not actively seeking work from September 9, 2018 through September 15, 2018 (decision # 75412). Claimant filed a timely request for hearing. On October 19, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for November 2, 2018. On November 2, 2018, claimant failed to appear at the hearing, and ALJ Scott issued Order No. 18-UI-119144, dismissing claimant's request for hearing because she failed to appear. On November 26, 2018, Order No. 18-UI-119144 became final without claimant having filed a timely request to reopen the November 2, 2018 hearing. On November 28, 2018, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on December 12, 2018 issued Order No. 18-UI-121148 denying the request as untimely without a showing of good cause. On December 26, 2018, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record and claimant's written argument. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-121148 is affirmed.
