

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0010

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On November 15, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 123104). On December 5, 2018, decision # 123104 became final without claimant having filed a request for hearing. On December 6, 2018, claimant filed a late request for hearing. On December 11, 2018, ALJ Kangas issued Order No. 18-UI-121065, dismissing claimant's request for hearing as untimely without a showing of good cause, subject to claimant's right to renew his request by filing a response to an appellant questionnaire by December 25, 2018. On December 19, 2018, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on December 20, 2018 issued Order No. 18-UI-121606, re-dismissing claimant's late request for hearing as without good cause. On December 28, 2017, claimant filed a timely application for review of Order No. 18-UI-121606 with the Employment Appeals Board (EAB).

Claimant failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). The argument also contained information that was not part of the hearing record, and failed to show that factors or circumstances beyond his reasonable control prevented him from including the information in his response to the appellant questionnaire. EAB therefore did not consider claimant's new information when reaching this decision. *See* ORS 657.275(2) and OAR 471-041-0090 (October 29, 2006).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-121606 is affirmed.
