

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0012

Affirmed
Late Request for Hearing Allowed
No Disqualification

PROCEDURAL HISTORY: On October 4, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 125841). On October 24, 2018, decision # 125841 became final without claimant having filed a request for hearing. On November 5, 2018, claimant filed a late request for hearing. On November 8, 2018, ALJ Kangas issued Order No. 18-UI-119398, dismissing claimant's request for hearing as untimely without a showing of good cause, subject to claimant's right to renew her request by responding to an appellant questionnaire by November 22, 2018. On November 14, 2018, claimant filed a timely response to the appellant questionnaire. On November 19, 2018, the Office of Administrative Hearings (OAH) cancelled and vacated Order No. 18-UI-119398, and on December 3, 2018 scheduled a hearing for December 17, 2018 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 125841. On December 17, 2018, ALJ Shoemaker conducted a hearing at which the employer failed to appear, and on December 21, 2018 issued Order No. 18-UI-121704, allowing claimant's late request for hearing and concluding that claimant's discharge was not for misconduct. On December 27, 2018, the employer filed an application for review of Order No. 18-UI-121704 with the Employment Appeals Board (EAB).

With its application for review, the employer submitted new information regarding claimant's discharge for EAB's consideration. Such information may be considered when the party offering the information establishes that factors or circumstances beyond its reasonable control prevented it from offering the information into evidence at the hearing. OAR 471-041-0090(2) (October 29, 2006). Here, the employer conceded that it failed to appear at the hearing due to a "clerical error" on its part, and not due to factor or circumstances beyond its reasonable control. EAB therefore did not consider the employer's new information when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-121704 is affirmed.
