

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0022**

*Reversed & Remanded*

**PROCEDURAL HISTORY:** On November 5, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision # 84301). The employer filed a timely request for hearing. On December 7, 2018, the Office of Administrative Hearings (OAH) served, by mail notice of a hearing scheduled for December 20, 2018. On December 20, 2018, ALJ Janzen conducted a hearing at which claimant failed to appear, and on December 21, 2017 issued Order No. 18-UI-121660, concluding that claimant's discharge was for misconduct. On January 3, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** Order No. 18-UI-121660 is reversed and this matter remanded for another hearing on whether claimant is disqualified from receiving benefits based on a work separation from the employer.

In his application for review, claimant requested a new hearing. Claimant's request is construed as a request for the consideration of new information regarding his work separation from the employer. Under OAR 471-041-0090(2) (October 29, 2006), such information may be considered when the party offering the information establishes that factors or circumstances beyond the party's reasonable control prevented the party from offering the information into evidence at the hearing.

In support of his request, claimant stated that he failed to appear at the December 20, 2018 hearing because he did not receive the December 7, 2018 notice of hearing. According to claimant, one of his roommates was stealing and disposing of the others' mail, including the notice of hearing, from October 2018 until being evicted in December 2018. Claimant was not aware that there had been a hearing until his weekly claims for benefits started being denied after December 21, 2018.

Claimant's statements are sufficient to establish that factors or circumstances beyond his reasonable control prevented him from appearing at the December 20, 2018 and offering information into evidence at that time. Claimant's request for consideration of new information regarding his work separation from the employer therefore is granted. Order No. 18-UI-121660 therefore is reversed, and this matter

remanded for another hearing on whether claimant is disqualified from receiving benefits based on a work separation from the employer.

**DECISION:** Order No. 18-UI-121660 is set aside, and this matter remanded for further proceedings consistent with this order.
