

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0031

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On November 2, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 93441). Claimant filed a timely request for hearing. On December 5, 2018, ALJ S. Lee conducted a hearing, and on December 7, 2018 issued Order No. 18-UI-120932, concluding the employer discharged claimant but not for misconduct. On December 27, 2018, Order No. 18-UI-120932 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On January 4, 2019, the employer filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than December 27, 2018. On January 4, 2019, the appellant filed an application for review of Order No. 18-UI-120932 with the Employment Appeals Board (EAB), as shown by the postmark date affixed to the envelope in which the employer mailed its application. OAR 471-041-0065(1)(b). The applicant's application for review was, therefore, late. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the applicant provided a written statement to EAB about claimant's work separation, the statement did not include any explanation why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-120932 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed January 4, 2019 is dismissed. Order No. 18-UI-120932 remains undisturbed.
