

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0035**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On October 15, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 111618). Claimant filed a timely request for hearing. On November 15, 2018, ALJ Wyatt conducted a hearing, and on November 21, 2018, issued Order No. 18-UI-120116, concluding claimant voluntarily left work without good cause. On December 11, 2018, Order No. 18-UI-120116 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 8, 2019, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On January 8, 2019, the appellant filed an application for review of Order No. 18-UI-120116 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than December 11, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-120116 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed January 8, 2019 is dismissed. Order No. 18-UI-120116 remains undisturbed.
