

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0036

Reversed & Remanded

PROCEDURAL HISTORY: On November 30, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 133615). Claimant filed a timely request for hearing. On December 13, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for December 27, 2018 to the parties at their addresses of record. On December 27, 2018, ALJ S. Lee conducted a hearing at which the employer failed to appear, and on January 3, 2018 issued Order No. 18-UI-122045, concluding the employer discharged claimant but not for misconduct. On January 8, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Order No. 18-UI-122045 is reversed and this matter remanded for a hearing on whether circumstances beyond the employer's reasonable control prevented it from appearing at the December 27, 2018 hearing and, if so, another hearing on the merits of decision # 133615.

With its application for review, the employer submitted new information regarding claimant's work separation. Under OAR 471-041-0090 (October 29, 2006), new information may be considered if the party offering the information shows it was prevented by circumstances beyond its reasonable control from offering the information into evidence at the hearing. The employer stated that it failed to appear at the hearing because it was not aware that there was a December 27, 2018 hearing scheduled until it received Order18-UI-122045.

The Employer asserted, "I understand that the notice to attend hearing was mailed to Pacific Stainless but as far as our records show we never received it." The employer's statement suggests that its failure to appear at the hearing might have been the result of factors or circumstances beyond its reasonable control. However, further inquiry is needed into the facts necessary for a determination of that issue. Order No. 18-UI-122045 therefore is reversed and this matter remanded for further proceedings to determine whether the December 27, 2018 hearing should be reopened and, if so, another hearing on the merits of decision # 133615.

DECISION: Order No. 19-UI-122045 is set aside, and this matter remanded for further proceedings consistent with this order.
