

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0040**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On October 3, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, not for misconduct (decision # 65949). The employer filed a timely request for hearing. On November 6, 2018, ALJ Frank conducted a hearing at which claimant failed to appear, and on November 14, 2019 issued Order No. 18-UI-119698, affirming the Department's decision. On November 16, 2018, the employer filed an application for review of Order No. 18-UI-119698 with the Employment Appeals Board (EAB). On December 7, 2018, claimant filed a late request to reopen the November 6<sup>th</sup> hearing with the Office of Administrative Hearings (OAH). On December 18, 2018, EAB issued EAB Decision 2018-EAB-1080, dismissing the employer's application for review of Order No. 18-UI-119698 without prejudice pending the outcome of claimant's late request to reopen the November 6<sup>th</sup> hearing. On December 26, 2018, OAH served notice of a hearing scheduled for January 8, 2019 on claimant's late request to reopen the November 6<sup>th</sup> hearing. On January 8, 2019, claimant failed to appear at the hearing, and on January 9, 2019, ALJ Frank issued Order No. 19-UI-122330, dismissing claimant's request for a reopening due to claimant's failure to appear. On January 9, 2018, the employer filed with EAB another application for review of Order No. 18-UI-119698, which affirmed the Department's decision that claimant's discharge by the employer was not misconduct.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

**DECISION:** Order No. 18-UI-119698 is affirmed.
