

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0045

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On May 25, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 81047). On June 14, 2018, decision # 81047 became final without claimant having filed a timely request for hearing. On November 29, 2018, claimant filed a late request for hearing. On December 6, 2018, ALJ Kangas issued Order No. 18-UI-120771 dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 20, 2018. On December 26, 2018, Order No. 18-UI-120771 became final without claimant having responded to the questionnaire or filed a timely application for review. On January 3, 2019, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 18-UI-120771 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On January 3, 2019, the appellant filed an application for review of Order No. 18-UI-120771 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than December 26, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although claimant filed a written statement in which he explained why he filed a late request for hearing on decision # 81047, he did not provide any explanation as to why the application for review of the hearing decision dismissing his request for hearing was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-120771 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed January 3, 2019 is dismissed. Order No. 18-UI-120771 remains undisturbed.
