

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0055**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On October 25, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 82354). Claimant filed a timely request for hearing. On November 30, 2018, ALJ Shoemake conducted a hearing, and on December 7, 2018 issued Order No. 18-UI-120907, concluding the employer discharged claimant but not for misconduct. On December 27, 2018, Order No. 18-UI-120907 became final without employer having filed an application for review with the Employment Appeals Board (EAB). On January 11, 2019, the employer filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On January 11, 2019, the appellant filed an application for review of Order No. 18-UI-120907 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than December 27, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). Although the appellant argued that it did not receive notice of the November 30<sup>th</sup> hearing, the appellant admitted that it received a copy of the ALJ’s Order allowing claimant benefits on December 12, 2018, well within the appeal period, but provided no explanation as to why the appellant waited until after the filing deadline displayed on the cover page of that Order had expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-120907 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed January 11, 2019 is dismissed. Order No. 18-UI-120907 remains undisturbed.
