

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0056**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On September 20, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was discharged but not for misconduct (decision # 73540). Claimant filed a timely request for hearing. On October 11, 2018, ALJ Janzen conducted a hearing, and on October 16, 2018 issued Order No. 18-UI-118236, concluding the employer discharged claimant but not for misconduct. On November 5, 2018, Order No. 18-UI-118236 became final without employer having filed an application for review with the Employment Appeals Board (EAB). On January 9, 2019, the employer filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On January 9, 2018, the appellant filed an application for review of Order No. 18-UI-118236 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than November 5, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant submitted a written statement regarding the work separation but provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-118236 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed January 9, 2019 is dismissed. Order No. 18-UI-118236 remains undisturbed.
