

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0057**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On September 30, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$223.00 overpayment, \$44.60 monetary penalty, and 8 penalty weeks (decision # 201066). On October 20, 2014, decision # 201066 became final without claimant having filed a timely request for hearing. On January 6, 2015, claimant filed a late request for hearing. On January 27, 2015, ALJ Kangas issued Order No. 15-UI-32400, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by February 10, 2015. On February 17, 2015, Order No. 15-UI-32400 became final without claimant having either responded to the questionnaire or filed a timely application for review of the order. On January 14, 2019, claimant filed a late application for review of Order No. 15-UI-32400 with the Employment Appeals Board.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On January 14, 2019, the appellant filed an application for review of Order No. 15-UI-32400 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than October 20, 2014. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed almost four years after the filing deadline expired. Accordingly, the application for review is dismissed, and EAB has no jurisdiction over decision # 201066 or claimant's overpayment penalties.

Order No. 15-UI-32400 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed January 14, 2019 is dismissed. Order No. 15-UI-32400 remains undisturbed.
