

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0083-R**

*EAB Decision 2019-EAB-0083 Adhered to on Reconsideration*  
*Order No. 19-UI-122378 Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On December 6, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 133415). Claimant filed a timely request for hearing. On January 4, 2019, ALJ Wyatt conducted a hearing at which the employer failed to appear, and on January 9, 2019, issued Order No. 19-UI-122378, concluding claimant voluntarily left work without good cause. On January 23, 2019, claimant filed an application for review with the Employment Appeals Board (EAB). On February 15, 2019, EAB issued EAB Decision 2019-EAB-0083, affirming Order No. 19-UI-122378. Later that day, EAB received a timely written argument from claimant that he had mailed to EAB on February 13, 2019. This decision is being issued to respond to claimant's timely written argument pursuant to EAB's authority under ORS 657.290(3) to reconsider any previous EAB Decision to correct a previous error.

In his written argument, claimant asked EAB to consider a document containing new information regarding the nature of his work separation from the employer. However, claimant failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Nor did claimant show, as required under OAR 471-041-0090(2) (October 29, 2006), that it was beyond his reasonable control to offer the document into evidence at the hearing, or offer the information contained in the document into evidence when testifying at the hearing. EAB therefore would not have considered claimant's written argument or new information when reaching its previous decision, and did not consider them when reaching this decision.

EAB Decision 2019-EAB-0083 therefore is adhered to on reconsideration.

**DECISION:** EAB Decision 2019-EAB-0083 adhered to on reconsideration. Order No. 19-UI-122378 is affirmed.
