

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0086

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On August 10, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$1590.00 overpayment, \$397.50 monetary penalty, and 11 penalty weeks (decision # 200835). On August 30, 2017, decision #200835 became final without claimant having filed a timely request for hearing. On December 17, 2018, claimant filed a late request for hearing. On December 26, 2018, ALJ Kangas issued Order No. 18-UI-121743, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by January 9, 2019. On January 15, 2019, Order No. 18-UI-121743 became final without claimant having responded to the questionnaire or filed an application for review with the Employment Appeals Board (EAB). On January 22, 2019, claimant responded to the appellant questionnaire. On January 24, 2019, ALJ Kangas issued a letter stating that claimant's response to the appellant questionnaire was untimely and would not be considered. This matter is before EAB pursuant to claimant's January 22, 2019 late response to the questionnaire, which we construe as an application for review under OAR 471-041-0060(1).

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On January 22, 2019, the appellant filed what has been construed as an application for review of Order No. 18-UI-121743 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than January 15, 2019. The deadline for filing a late application for review may be extended if the party filing the late application for review shows "good cause" for the late filing, which is defined as "evidence that factors or circumstances beyond the applicant's reasonable control prevented timely filing." OAR 471-041-0070(2)(a).

Claimant wrote "I'm sorry if this appeal is late I have been trying hard to get this right so you could help me." Claimant's statement identified the reason for the late filing, but did not describe a factor or circumstance that was beyond his reasonable control or otherwise identify why his efforts to "get this right" prevented him from filing either by the January 9th questionnaire deadline or the January 15th

application for review deadline. In the absence of a showing of good cause, the application for review must be dismissed.

DECISION: The application for review filed January 22, 2019 is dismissed. Order No. 18-UI-121743 remains undisturbed.
