EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0096

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On July 18, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 123004). Claimant filed a timely request for hearing. On November 2, 2017, ALJ Lewis conducted a hearing, and on November 6, 2017 issued Order No. 17-UI-96275, affirming the Department's decision. On November 27, 2017, Order No. 17-UI-96275 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 24, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On January 24, 2019, the appellant filed an application for review of Order No. 17-UI-96275 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than November 27, 2017. Claimant's application for review was therefore filed late.

The deadline for filing a late application for review may be extended if claimant shows "good cause" for the late filing, which means that factors or circumstances beyond her reasonable control prevented timely filing, and that she filed the late application within "a reasonable time," which means seven days after the circumstances that prevented a timely filing ceased to exist. *See* ORS 657.875, OAR 471-041-0070(2)(a)-(b).

Claimant filed her application for review when she did because she learned new information about her former employer from the Oregon State Ethics Commission in January 2019. She did not suggest any reason why she could not have filed her application for review prior to the November 27, 2017 filing deadline, however, even though she did not have the new information currently in her possession. Filing

an application for review and providing new information to EAB are two distinct processes that involve two distinct administrative rules. Nothing in claimant's written statement suggests that filing a timely application for review of Order No. 17-UI-96275 – without the additional information claimant now possesses – was beyond claimant's reasonable control. There is no basis in the law, EAB's rules, or EAB's prior practice for suspending or extending the application for review deadline while waiting for new information that might or might not affect the case's outcome. The fact that the new information was not available to claimant until January 2019 therefore does not amount to good cause for the late filing.

Even if we had decided otherwise, claimant's late application for review would still have to be dismissed because she did not establish that her filing occurred within the seven-day "reasonable time" period. Although claimant's written statement states that the new information that triggered her decision to file a late application for review became available in January 2019, her statement does not state when in January 2019 the information became available, or that it became available to her within seven days of the January 24th late application for review filing date.

Order No. 17-UI-96275 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed January 24, 2019 is dismissed. Order No. 17-UI-96275 remains undisturbed.
