**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0098**

*Affirmed*  
*Adjustment of Claim Determination Denied*

**PROCEDURAL HISTORY:** On May 10, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to adjust her claim determination, and add wages and hours of work to her claim for purposes of establishing a valid claim and the minimum and maximum benefit amounts payable under such a claim. On May 19, 2017, claimant filed a timely request for hearing. On December 18, 2018, ALJ Wyatt conducted a hearing, and on December 26, 2018 issued Order No. 18-UI-121785, affirming the Department's decision.<sup>1</sup> On January 15, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).<sup>2</sup>

The parties jointly submitted written argument to EAB in support of claimant's request to adjust her claim determination and add wages and hours of work based upon claimant's work for the employer in this case. In that argument, the parties asked EAB to investigate, take jurisdiction, or intervene in cases involving the parties' interactions with the Department of Human Services, Internal Revenue Service, Lane County, Medicaid, matters that have been previously handled by other entities concerning claims under ORS

chapter 656, an overpayment debt assessed by DHS, matters involving the Employee Relations Board, civil claims, and the parties' claims of marriage, pregnancy, and disability discrimination. The parties also requested that EAB transfer jurisdiction in this case to a District Court or the Oregon appellate courts.

EAB does not have jurisdiction to do any of the things the parties requested. EAB does not have an investigatory function, and the parties' request that EAB intervene in other matters affecting the parties and/or refer this case to the judicial branch of government are all outside EAB's jurisdiction and are therefore denied. The narrow issue before EAB, and the only matter over which EAB has jurisdiction, is reviewing *de novo* the record compiled at the December 19, 2018 unemployment insurance benefit hearing to determine whether claimant's wages from work with the employer were excluded from the definition of "employment" as set forth in ORS 657.060(1). *See* ORS 657.275 (defining the scope of review in EAB cases).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

**DECISION:** Order No. 18-UI-121785 is affirmed.
