

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0105

Affirmed - Afirmada
Late Request for Hearing Dismissed - Petición Tardia para Audiencia es Negada

PROCEDURAL HISTORY: On June 13, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$271 overpayment that claimant was required to repay (decision # 141825). On July 3, 2018, decision # 141825 became final without claimant having filed a request for hearing. On November 16, 2018, claimant filed a late request for hearing. On November 27, 2018, ALJ Kangas issued Order No. 18-UI-120288, dismissing claimant's request for hearing as untimely without a showing of good cause subject to her right to renew the request by responding to an appellant questionnaire by December 11, 2018. On December 10, 2018, claimant filed a timely response to the appellant questionnaire. On December 13, 2018, the Office of Administrative Hearings (OAH) cancelled Order No. 18-UI-120288, and on December 26, 2018 scheduled a hearing for January 8, 2019. On January 8, 2019, ALJ Janzen conducted a hearing, and on January 9, 2019 issued Order No. 19-UI-122351, re-dismissing claimant's late request for hearing on decision # 141825 as untimely without good cause. On January 28, 2019, claimant filed an application for review of Order No. 19-UI-122351 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-122351 is affirmed. *La Orden de la Audiencia 19-UI-122351 queda confirmada.*
