EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0106

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 12, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision #81140). The employer filed a timely request for hearing. On November 16, 2018, ALJ Janzen conducted a hearing at which claimant failed to appear, and on November 20, 2018 issued Order No. 18-UI-120026, concluding that claimant's discharge was for misconduct. On December 4, 2018, claimant filed a timely request to reopen the November 16, 2018 hearing. On December 27, 2018, ALJ Meerdink conducted a hearing, and on January 9, 2019 issued Order No. 19-UI-122326, granting claimant's request for a reopening and concluding that her discharge was for misconduct. On January 29, 2019, Order No. 19-UI-122326 became final without claimant having filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 19-UI122326 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. OAR 471-041-0070(1) (March 20, 2014). The 20-day filing period may be extended upon a showing of "good cause." OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing OAR 471-040-0070(2)(a).

Claimant filed her application for review of Order No. 19-UI-122326 one day late, asserting that she had "technical difficulties faxing this through a machine and have had to move to this online method of faxing." However, claimant failed to state when she attempted to fax her application for review using

the fax machine, what technical difficulties she experienced, or what efforts, if any, she then made to file a timely application for review by another method. Absent such information, claimant failed to show that the technical difficulties she experienced were beyond her reasonable control, or that they prevented her from filing a timely application for review. Claimant therefore failed to establish good cause to extend the deadline for filing her application for review.

Claimant's late application for review is dismissed. Order No. 19-UI-122326 remains undisturbed, and EAB will take no further action in this matter.

DECISION: The application for review filed January 30, 2019 is dismissed. Order No. 19-UI-122326 remains undisturbed.
