# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0106-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 12, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision #81140). The employer filed a timely request for hearing. On November 16, 2018, ALJ Janzen conducted a hearing at which claimant failed to appear, and on November 20, 2018 issued Order No. 18-UI-120026, concluding that claimant's discharge was for misconduct. On December 4, 2018, claimant filed a timely request to reopen the November 16, 2018 hearing. On December 27, 2018, ALJ Meerdink conducted a hearing, and on January 9, 2019 issued Order No. 19-UI-122326, granting claimant's request for a reopening and concluding that her discharge was for misconduct. On January 29, 2019, Order No. 19-UI-122326 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 30, 2019, claimant filed a late application for review with the Employment Appeals Board (EAB). On February 7, 2019, EAB issued EAB Decision 2019-EAB-0106, dismissing claimant application for review as late without good cause. On March 4, 2019, claimant filed a request for reconsideration.

**CONCLUSIONS AND REASONS:** Claimant's late request for reconsideration of EAB Decision 2019-EAB-0106 is dismissed.

ORS 657.290(3) gives EAB the authority to reconsider its decisions. OAR 471-041-0125 (October 29, 2006) provides:

(1) Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice.

- (2) The request is subject to dismissal unless it:
- (a) Includes a statement that a copy has been provided to the other parties. Example: "I certify that on I mailed by first class mail a copy of this document to the opposing party, addressed as follows: ABC Company, 123 Main St., Portland, OR, 9XXXX."
- (b) Is filed on or before the 20th day after the decision sought to be reconsidered is mailed.

EAB Decision 2019-EAB-0106 was served on February 7, 2019. The 20-day deadline for filing a request for reconsideration therefore was February 27, 2019. Claimant filed her request for reconsideration on March 4, 2019. Claimant's request for reconsideration therefore is late, and must be dismissed. EAB Decision 2019-EAB-0106 and Order No. 19-UI-122326 remain undisturbed, and EAB will take no further action in this matter.

**DECISION:** The request for reconsideration filed March 4, 2019 is dismissed. EAB Decision 2019-EAB-0106 and Order No. 19-UI-122326 remain undisturbed.
