EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0109

Affirmed No Disqualification

PROCEDURAL HISTORY: On October 31, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 152349). Claimant filed a timely request for hearing. On January 22, 2019, ALJ Murdock conducted a hearing, and on January 30, 2019, issued Order No. 19-UI-123685, concluding claimant voluntarily left work with good cause. On February 1, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) North Clackamas School District #12 employed claimant as an on-call substitute custodian from August 27, 2015 until June 11, 2018.

(2) Claimant suffered from a thyroid disease that affected his hormones, physical responses, cognitive functioning, and mental state. It caused him limitations in memory and emotional control, difficulty processing information, tinnitus, "crying fits" and to "even hear...things" sometimes. Transcript at 13, 33. Claimant had lost ninety pounds over the prior year and had been on a regular course of medications for his condition that had persisted for years. He had also been diagnosed with depression and severe anxiety. Claimant often missed work due to his medical conditions. His treating physician advised him that working at his job in his condition was detrimental enough to his health that that continuing to work for the employer was "up to [claimant]" and that she would support any decision that he made regarding his employment. Transcript at 11.

(3) During the first half of 2018, claimant increasingly began missing more and more work, and when he did work his scheduled shifts he had difficulty doing anything after working but going home and sleeping. He also had at least one coworker file a complaint about him concerning what was perceived by the coworker as irrational and potentially threatening behavior. Claimant's supervisor scheduled a meeting with claimant for June 11, 2018 to discuss his work issues. During the meeting, as the discussion began, claimant became overcome with feelings of paranoia, dread, and fear that he might lose control of his emotions and react with hostility. Rather than risk doing so and to protect his health, he abruptly left the meeting and quit.

CONCLUSIONS AND REASONS: We agree with the ALJ. Claimant voluntarily left work with good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless he (or she) proves, by a preponderance of the evidence, that he had good cause for leaving work when he did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). "Good cause" is defined, in relevant part, as a reason of such gravity that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would have no reasonable alternative but to leave work. OAR 471-030-0038(4) (January 11, 2018). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P2d 722 (2010). Claimant had been diagnosed with thyroid disease, anxiety and depression, permanent or long-term "physical or mental impairment[s]" as defined at 29 CFR §1630.2(h). A claimant with such impairments who quits work must show that no reasonable and prudent person with the characteristics and qualities of an individual with such impairments would have continued to work for the employer for an additional period of time.

During the June 11 meeting, claimant recognized that he was having difficulty processing the critical information he was being confronted with and becoming overwhelmed with feelings of paranoia and dread. He also recognized that he might lose control of his emotions and react with hostility. Rather than continue with the meeting under those circumstances, and to protect his long-term health, he abruptly quit. Claimant demonstrated that he faced a grave situation at that time and place, given his diagnosed medical conditions, his history of difficulty in controlling his emotions and the feelings of paranoia and dread he was experiencing at that time. Claimant's treating physician had advised him that continuing to work at his job with his medical conditions was detrimental enough to his health that whether he continued to work for the employer was "up to [him]." Viewed objectively, claimant demonstrated that no reasonable and prudent person with the characteristics and qualities of an individual with his impairments would have continued to work for the employer for an additional period of time.

Claimant voluntarily left work with good cause and is not disqualified from receiving unemployment insurance benefits based on his work separation.

DECISION: Order No. 19-UI-123685 is affirmed.
