EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0112

Affirmed Disqualification

PROCEDURAL HISTORY: On November 21, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 83957). Claimant filed a timely request for hearing. On January 15, 2019, ALJ Frank conducted a hearing, and on January 23, 2019 issued Order No. 19-UI-123195, affirming the Department's decision. On January 31, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument, but failed to certify that he provided a copy of it to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). For that reason, EAB did not consider the argument when reaching this decision.

FINDINGS OF FACT: (1) Airgas USA LLC employed claimant as a production operator from May 13, 2013 until October 26, 2018. Claimant worked for the employer at a site in Oregon and resided near Portland, Oregon.

(2) Sometime before the summer of 2018, claimant and his wife decided to move from Oregon to Oklahoma. Both had relatives in Oklahoma and wanted to live nearer to them.

(3) Around or before this time, claimant inquired of the employer's human resources manager if it was possible for him to transfer to one of the employer's business locations in Oklahoma. The human resources manager told claimant that he could not be transferred to an Oklahoma location since the employer's businesses in that state were organized under an entity that was separate from that under which the Oregon locations were organized. Claimant was informed that he would need to apply for work in Oklahoma as a new prospect, and the Oklahoma operation would decide whether or not to hire him.

(4) On June 1, 2018, claimant listed his house in Oregon for sale. On August 31, 2018, claimant and his wife closed on a house in Oklahoma. Around early September 2018, claimant began making repairs and upgrades to his house in Oregon to improve its sale prospects.

(5) On September 18, 2018, claimant notified the employer that he was going to quit work effective October 19, 2018. However, the employer later allowed claimant to move back the effective date of his leaving to October 26, 2018. Claimant voluntarily left work on October 26, 2018.

(6) Claimant stayed in Oregon until December 12, 2018, working on his Oregon house and preparing to move to Oklahoma. On December 13, 2018, claimant left Oregon for Oklahoma in a moving truck. Claimant arrived in Oklahoma on December 17, 2018 and took up residence in Oklahoma.

CONCLUSIONS AND REASONS: Claimant voluntarily left work without good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless he proves, by a preponderance of the evidence, that he had good cause for leaving work when he did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). "Good cause" is defined, in relevant part, as a reason of such gravity that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would have no reasonable alternative but to leave work. OAR 471-030-0038(4) (January 11, 2018). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P3d 722 (2010). A claimant who quits work must show that no reasonable and prudent person would have continued to work for his employer for an additional period of time.

Although claimant may have wanted to relocate to Oklahoma for valid personal reasons, he did not describe any objectively grave reasons for the move. That claimant and his wife may have wanted to live in closer proximity to relatives in Oklahoma does not, without more, suggest that either faced a situation of gravity if claimant remained in Oregon and continued to work. On this record, claimant did not meet his burden to show that grave reasons motivated his decision to leave work on October 26. Because he did not show good cause for leaving, claimant is disqualified from receiving benefits based on this work separation.

DECISION: Order No. 19-UI-123195 is affirmed.
