

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0119

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On November 14, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 103039). Claimant filed a timely request for hearing. On December 19, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for January 4, 2019. On January 4, 2019, ALJ R. Frank conducted a hearing, and on January 10, 2019 issued Order No. 19-UI-122443, concluding that claimant voluntarily left work with good cause. On January 30, 2019, Order No. 19-UI-122443 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On January 31, 2019, the employer filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

ORS 657.270(6) and ORS 657.270(7)(c) required the employer's application for review in this case to be filed no later than January 30, 2019. The filing date of an application for review filed by mail is determined according to the postmark date on the envelope in which the application for review was mailed. OAR 471-041-0005(1)(b). The postmark date on the envelope in which the employer filed its application for review in this case was January 31, 2019, making the filing one day late. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the employer included a statement in its application for review addressing its failure to appear at the January 4th hearing, the employer's statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed January 31, 2019 is dismissed. Order No. 19-UI-122443 remains undisturbed.
