EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0123

Affirmed No Disqualification

PROCEDURAL HISTORY: On November 26, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work with good cause (decision # 152626). The employer filed a timely request for hearing. On January 11, 2019, ALJ Wyatt conducted a hearing, and on January 16, 2019 issued Order No. 19-UI-122865, affirming the Department's decision. On February 5, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB considered the employer's written argument when reaching this decision.

FINDINGS OF FACT: (1) Luxottica Retail North America, Inc. employed claimant as a Sunglass Hut store employee until October 30, 2018.

(2) At all relevant times, claimant's primary source of employment was Point Blank Distributing, where she typically worked 35-40 hours per week and earned \$14.00 per hour. Point Blank posted claimant's scheduled work hours one week in advance, and typically scheduled claimant to work from 12:00 p.m. to 6:00 p.m. or 7:00 p.m. Tuesdays through Saturdays.

(3) Claimant worked part-time for the employer and earned \$11.50 per hour. She usually worked 22-27 hours per week, although her hours declined when a new store manager began working.

(4) Because claimant had another, primary job, she notified the employer she preferred to work eight hour shifts on Sundays and Mondays. The general manager often wanted to schedule claimant to work weekdays and Saturdays from 4:00 p.m. or 5:15 p.m. to 8:00 p.m. or 8:15 p.m., which conflicted with her primary job. The general manager posted the schedules two or three weeks in advance.

(5) Claimant could not work her scheduled part-time hours with the employer and work when scheduled at her primary job. On October 30, 2018, claimant quit work with the employer so she could continue to work as scheduled at her primary job.

CONCLUSIONS AND REASONS: Claimant voluntarily left work with good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless she proves, by a preponderance of the evidence, that she had good cause for leaving work when she did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). "Good cause" is defined, in relevant part, as a reason of such gravity that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would have no reasonable alternative but to leave work. OAR 471-030-0038(4) (January 11, 2018). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P3d 722 (2010). A claimant who quits work must show that no reasonable and prudent person would have continued to work for her employer for an additional period of time.

Claimant quit working for the employer because her part-time hours with the employer were incompatible with the hours she was scheduled to work at her primary job. Claimant had asked the employer to modify her hours, but the general manager was either not willing or not able to accommodate claimant's limited availability. No reasonable and prudent person would continue working under 27 hours per week earning \$11.50 per hour at a second or supplemental job when doing so interfered with the individual's availability to work up to 40 hours a week and earning \$14.00 per hour at her primary job. Claimant therefore voluntarily quit work with good cause, and she is not disqualified from receiving unemployment insurance benefits because of her work separation.

DECISION: Order No. 19-UI-122865 is affirmed.
