EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0131

Application for Review Dismissed

Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision #83931). On December 10, 2018, decision #83931 became final without claimant having filed a timely request for hearing. On December 11, 2018, claimant filed a late request for hearing. On December 13, 2018, ALJ Kangas issued Order No. 18-UI-121192, dismissing claimant's late request for hearing subject to his right to renew the request by responding to an appellant questionnaire by December 27, 2018. Claimant did not respond to the questionnaire, and on January 2, 2019, Order No. 18-UI-121192 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On February 1, 2019, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings (OAH) and a late application for review with EAB. On February 6, 2019, OAH mailed a letter to claimant stating that his questionnaire response was late and would not be considered. This matter is before EAB on claimant's February 1, 2019 late application for review.¹

CONCLUSIONS AND REASONS: The application for review should be dismissed.

ORS 657.270(6) and ORS 657.270(7)(c) required claimant's application for review in this case to be filed no later than January 2, 2019. Claimant filed his application for review with EAB on February 1, 2019, a month late.

The deadline for filing a late application for review may be extended if factors or circumstances beyond claimant's reasonable control prevented a timely filing, and if he filed his late application for review within seven days of the date those circumstances ceased to exist. ORS 657.875; OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3).

¹ On February 11, 2019, EAB mailed the parties a letter stating that claimant had filed a "timely" application for review in this case. That letter was sent in error, as claimant's application for review was not timely filed.

Although claimant included a written statement with his application for review, that statement consisted only of his responses to the appellant questionnaire and did not include any statement explaining why he filed his application for review (or appellant questionnaire responses) a month late. Because claimant provided no explanation as to why the application was filed after the filing deadline expired, or when the circumstances that prevented a timely filing ceased to exist, he has not shown good cause to extend the filing deadline and his application for review must be dismissed.

DECISION: The application for review filed February 1, 2019 is dismissed. Order No. 18-UI-121192 remains undisturbed.
