PROCEDURAL HISTORY FOR DECISION # 134526: On November 30, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 134526). Claimant filed a timely request for hearing. On December 10, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 134526 scheduled for December 27, 2018 at 9:30 a.m. On December 27, 2018, ALJ Frank attempted to conduct the hearing on decision # 134526, and issued Order No. 18-UI-121825, dismissing claimant's request for hearing due to his failure to appear at the hearing. Claimant filed a timely request to reopen the hearing. On January 24, 2019, ALJ Frank conducted a hearing on decision # 134526, and on January 30, 2019 issued Order No. 19-UI-123646, allowing claimant's request to reopen the hearing and affirming the Department's decision # 134526.

PROCEDURAL HISTORY FOR DECISION # 140631: On November 30, 2018, the Department issued another administrative decision concluding that claimant was ineligible to receive benefits beginning November 4, 2018 until the reason for the denial had ended, because he was receiving or would be receiving retirement pay (decision # 140631). Claimant filed a timely request for hearing. On December 27, 2018, ALJ Frank conducted a hearing, which was continued to January 10, 2019. On January 10, 2019, ALJ Frank reconvened the hearing on decision # 140631, and on January 18, 2019 issued Order No. 19-UI-123034, modifying the Department's decision to include additional weeks claimed, and concluding that claimant was ineligible for benefits for the period of November 4, 2018 through December 15, 2018.

On February 7, 2019, claimant filed applications for review of Order No. 19-UI-123646 and Order No. 19-UI-123034 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order No. 19-UI-123646 and Order No. 19-UI-123034. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0144 and 2019-EAB-0145).

On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Order No. 19-UI-123646 and Order No. 19-UI-123034 are affirmed.
