

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0158**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On December 6, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct (decision # 120157). Claimant filed a timely request for hearing. On December 24, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 7, 2019. On January 7, 2019, claimant failed to appear at the hearing, and ALJ Snyder issued Order No. 19-UI-122228, dismissing claimant's request for hearing due to his failure to appear. Claimant filed a timely request to reopen the hearing. ALJ Kangas reviewed claimant's request to reopen, and on January 29, 2019, issued Order No. 19-UI-123575, denying his request. On February 2, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. With his application for review, claimant submitted new information regarding his failure to appear at the January 7, 2019 hearing. However, claimant failed to show that factors or circumstances beyond his reasonable control prevented him from offering the information into the hearing record in his request to reopen the hearing. EAB therefore did not consider claimant's new information when reaching this decision. *See* OAR 471-041-0090 (October 29, 2006).

On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Order No. 19-UI-123575 is affirmed.
