

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0161**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On November 16, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 102753). Claimant filed a timely request for hearing. On December 19, 2018, ALJ Snyder conducted a hearing, and on January 10, 2019 issued Order No. 19-UI-122484, concluding the employer discharged claimant for misconduct. On January 30, 2019, Order No. 19-UI-122484 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 12, 2019, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On February 12, 2019, the appellant filed an application for review of Order No. 19-UI-122484 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than January 30, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). Although the appellant included a written statement with her application for review, the statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 19-UI-122484 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed February 12, 2019 is dismissed. Order No. 19-UI-122484 remains undisturbed.
