# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0162

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On July 29, 2010, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$720 overpayment. On August 18, 2010 the administrative decision became final without claimant having filed a timely request for hearing. On December 7, 2018, claimant filed a late request for hearing. On December 11, 2018, ALJ Kangas issued Order No. 18-UI-121061, dismissing claimant's late request for hearing subject to claimant's right to review the request by responding to an appellant questionnaire by December 25, 2018. On December 21, 2018, claimant responded to the appellant questionnaire. On December 28, 2018, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 18-UI-121061 was canceled. On December 31, 2018, OAH mailed notice of a hearing scheduled for January 15, 2019. On January 15, 2019, ALJ S. Lee conducted a hearing, and on January 18, 2019, issued Order No. 19-UI-123070, allowing claimant's late request for hearing and affirming the Department's assessment of the \$720 overpayment. On February 7, 2019, Order No. 19-UI-123070 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On February 13, 2019, claimant filed a late application for review with EAB.

#### **CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On February 13, 2019, the appellant filed an application for review of Order No. 19-UI-123070 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than February 7, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

We note that claimant's application for review was primarily to request for relief from garnishment and overpayment collection activities undertaken by the Department on the grounds that the collection is causing a financial hardship to claimant. Claimant's request falls outside the boundaries of EAB's jurisdiction, and we are therefore unable to take the kind of action claimant requested. That would still

be the case even if we had not dismissed claimant's application for review. However, we have sent a copy of claimant's request to the Department's overpayment collections unit. If claimant has any questions about the garnishment or other collections activities associated with her overpayment(s), she must contact the overpayment collections unit directly by calling (503) 947-1995.

Order No. 19-UI-123070 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed February 13, 2019 is dismissed. Order No. 19-UI-123070 remains undisturbed.
