

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0173**

*Affirmed*  
*Requests to Reopen Denied*

**PROCEDURAL HISTORY:** On November 30, 2018, the Oregon Employment Department (the Department) served notice of and an administrative decision concluding that claimant voluntarily quit working for Anderson Structures LLC (the employer) without good cause (decision # 151514). On December 3, 2018, the Department served notice of an administrative decision concluding that claimant was not available for work from September 23, 2018 through November 24, 2018 (decision # 70758). Claimant filed timely requests for hearing on both decisions. On December 26, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 8, 2019 at 10:45 a.m. on decision # 151514, and notice of a hearing scheduled for January 8, 2019 at 9:30 a.m. on decision #70758. On January 8, 2019, claimant failed to appear at both hearings, and ALJ Scott issued Order No. 19-UI-122302, dismissing claimant's request for hearing on decision # 70758 due to his failure to appear. On January 10, 2019, ALJ Scott issued Order No. 19-UI-122512, dismissing claimant's request for hearing on decision # 151514 due to his failure to appear. On January 30, 2019, claimant filed a timely request to reopen the hearing on decision # 151514 and a late request to reopen the hearing on decision # 70758. ALJ Kangas reviewed claimant's requests to reopen, on February 7, 2019 issued Order No. 19-UI-124240 denying his request to reopen the hearing on decision # 151514, and on February 8, 2019 issued Order No. 19-UI-124260 denying his request to reopen the hearing on decision # 70758. On February 19, 2019, claimant filed timely applications for review of Order No. 19-UI-124240 and Order No. 19-UI-124260 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order No. 19-UI-124240 and Order No. 19-UI-124260. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0173 and 2019-EAB-0174).

On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Order No. 19-UI-124240 and Order No. 19-UI-124260 are affirmed.
