

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0195**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On December 12, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 82723). Claimant filed a timely request for hearing. On February 7, 2019, ALJ Frank conducted a hearing at which the employer did not appear, and on February 15, 2019 issued Order No. 19-UI-124788, affirming the Department's decision. On February 21, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument that offered a new reason for why she left work and that contained other information not offered into evidence during the hearing. Claimant did not explain why she did not raise this additional reason for leaving in response to the ALJ's open-ended question at hearing asking her why she quit when she did. Audio at ~8:18. With respect to this and the other new information that claimant sought to present to EAB, claimant also did not show, as required by OAR 471-041-0090(2) (October 29, 2006), that factors or circumstances beyond her reasonable control prevented her from offering that new reason and other new information at hearing.

Claimant also stated in her argument that she did not offer into evidence the employment records that the employer maintained on her because an employer representative told her that she did not need them for the hearing. However, since the basis for the ALJ's decision was that claimant left work due to a new job offer and that offer was not definite within the meaning of OAR 471-030-0038(5)(a) (January 11, 2018), the employer's records would not appear to be relevant to issues on which EAB has reviewed this matter. For these reasons, EAB did not consider the new reasons and information that claimant sought to present by way of her written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

**DECISION:** Order No. 19-UI-124788 is affirmed.
