EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0204

Order No. 124757 Affirmed
Disqualification

PROCEDURAL HISTORY: On January 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 83727). On January 17, 2019, the Department served notice of a separate administrative decision concluding claimant was not available for work from January 6 through January 12, 2019 (decision # 125245). Claimant filed timely requests for hearing on both decisions. On February 8, 2019, ALJ Wyatt conducted separate hearings, and on February 15, 2019 issued Order No. 19-UI-124757 affirming decision # 83727, and Order No. 19-UI-124756 concluding claimant was not available for work from January 6 through February 2, 2019. On February 20, 2019, claimant filed an application for review of each order with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095, EAB consolidated its review of Order Nos. 19-UI-124757 and 19-UI-124756. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0202 and 2019-EAB-0204, respectively).

In support of her applications for review, claimant submitted a written argument. Claimant failed to certify that she provided a copy of her argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). The argument also contained information that was not part of the hearing record, and failed to show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090. We considered only information received into evidence at the hearings, and claimant's argument only to the extent it was based thereon, when reaching this decision. *See* ORS 657.275(2).

EAB reviewed both hearing records in their entirety. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order Nos. 19-UI-124757 and 19-UI-124756 are affirmed.
