

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0205

Affirmed
Disqualification

PROCEDURAL HISTORY: On January 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 100151). Claimant filed a timely request for hearing. On February 12, 2019, ALJ S. Lee conducted a hearing, and on February 15, 2019 issued Order No. 19-UI-124829, affirming the Department's decision. On February 25, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument when reaching this decision.

FINDINGS OF FACT: (1) Iron Triangle, LLC employed claimant as an equipment operator from January 16, 2018 until March 30, 2018.

(2) When claimant was hired, he and a partner operated a side business installing bathtubs for a general contractor. At hire, the employer told claimant that he was required to work Mondays through Fridays and sometimes on Saturdays. Claimant intended to work at the side business on Saturdays and Sundays. Claimant told the employer that he might need to take Saturdays off "here and there." Audio at ~14:31. The employer expected claimant to alternate working on Saturdays with two coworkers.

(3) Sometime before March 30, 2018, claimant's partner withdrew from the side business, leaving claimant responsible for completing the jobs that the business had agreed to perform. Between claimant's hire date and March 30, 2018, he worked only one Saturday. The employer scheduled claimant to work on Saturday, March 31, 2018. However, claimant had agreed to perform bathtub installation work for the general contractor on March 31. Claimant asked, but his coworkers were unwilling to work in his place on March 31.

(4) On March 30, 2018, claimant asked the employer's manager if he could have March 31 off since his coworkers had refused to work on that Saturday. The manager refused. Claimant notified the manager that he was quitting work, effective that day. Claimant quit work because he was unwilling to call off the work he had arranged to perform for his side business on March 31.

CONCLUSIONS AND REASONS: Claimant voluntarily left work without good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless he proves, by a preponderance of the evidence, that he had good cause for leaving work when he did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). “Good cause” is defined, in relevant part, as a reason of such gravity that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would have no reasonable alternative but to leave work. OAR 471-030-0038(4) (January 11, 2018). Leaving work without good cause includes leaving work for self employment. OAR 471-030-0038(5)(a)(G). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P3d 722 (2010). A claimant who quits work must show that no reasonable and prudent person would have continued to work for his employer for an additional period of time.

Claimant left work for the employer because the employer required him to work on a day that he had arranged to perform work on behalf of his side business. From claimant’s description of the side business, it appears that it was a self-employment venture. OAR 471-030-0038(5)(a)(G) expressly provides that it is not good cause to leave existing work for self-employment, and that prohibition logically extends to leaving work, as claimant did, due to conflicting obligations undertaken in the course of a self-employment venture. On this record, claimant did not show that he had good cause for leaving work when he did. Claimant is disqualified from receiving unemployment insurance benefits.

DECISION: Order No. 19-UI-124829 is affirmed.
