

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0207

Affirmed
No Disqualification

PROCEDURAL HISTORY: On November 5, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 144718). Claimant filed a timely request for hearing. On January 25, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for February 5, 2019. On February 5, 2019, ALJ Murdock conducted a hearing, at which the employer failed to appear, and on February 8, 2019 issued Order No. 19-UI-124258, concluding claimant's discharge was not for misconduct. On February 22, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

With its application for review the employer asked that the hearing be reopened. The employer's request is construed as a request to have EAB consider new information under OAR 471-041-0090 (October 29, 2006), which allows EAB to consider information not presented at the hearing if the party offering the information shows it was prevented by circumstances beyond its reasonable control from presenting the information at the hearing. In support of its request, the employer stated that the original notice was mailed to the employer's corporate office in Illinois, and the employer's representative was "just becoming aware of this." The employer's representative did not suggest that the address to which the Department and OAH mailed prior notices in this case was not an address associated with the employer's business, however, and it is generally considered within an employer's reasonable control to timely manage mail directed to its various offices. The employer has not shown that circumstances beyond its reasonable control prevented the employer from receiving the original notice or appearing at the hearing to provide evidence about claimant's work separation. The employer's request for EAB to consider new information is, therefore, denied.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-124258 is affirmed.
