

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0211**

*Affirmed*  
*Late Request to Reopen Dismissed*

**PROCEDURAL HISTORY:** On March 23, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 103012). On March 26, 2018, the Department served notice of an administrative decision concluding that claimant willfully failed to report earnings and his work separation from the employer, and therefore was overpaid \$1480 in benefits that he must repay, is disqualified for 14 weeks of future benefits, and assessed a \$222 monetary penalty (decision # 193960). Claimant filed a timely request for hearing on both decisions. On April 23, 2018, the Office of Administrative Hearings (OAH) served notice of two hearings scheduled for May 7, 2018. On May 7, 2018, claimant failed to appear at the hearings, and ALJ S. Lee issued Order No. 18-UI-108821 and Order No. 18-UI-108822, dismissing claimant's requests for hearings on decision # 103012 and decision # 193960 due to claimant's failure to appear. On May 29, 2018, Order No. 18-UI-108821 and Order No. 18-UI-108822 became final without claimant having filed a request to reopen the hearings. On February 7, 2019, claimant filed a late request to reopen the hearings. On February 11, 2019, ALJ Kangas issued Order No. 19-UI-124441, dismissing claimant's request to reopen the hearing on decision # 103012 as late without good cause. On February 13, 2019, ALJ Kangas issued Order No. 19-UI-124600, dismissing claimant's request to reopen the hearing on decision # 193960 as late without good cause. On February 19, 2019, claimant filed a timely application for review of Order No. 19-UI-124441 and Order No. 19-UI-124600 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order No. 19-UI-124441 and Order No. 19-UI-124600. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0210 and 2019-EAB-0211).

EAB considered both hearing records. Claimant submitted written argument with his application for review but failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). The argument also contained information that was not part of the hearing record and failed to show that factors or circumstances beyond claimant's reasonable control prevented from offering the information into the hearing record, as required by OAR 471-041-0090(2)(b) (October 29, 2006). Nor is claimant's new information relevant to whether claimant had

good cause for filing late requests to reopen the May 7, 2018 hearings on decision # 103012 and decision # 193960, as required by OAR 471-041-0090(2)(a). EAB therefore did not consider claimant's written argument or new information when reaching this decision.

On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Order No. 19-UI-124441 and Order No. 19-UI-124600 are affirmed.
