

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0231

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On September 5, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 85258). On September 25, 2018, decision # 85258 became final without claimant having filed a timely request for hearing. On November 28, 2018, claimant filed a late request for hearing. On December 3, 2018, ALJ Kangas issued Order No. 18-UI-120595, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by December 17, 2018. On December 17, 2018, claimant responded to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on December 27, 2018, issued Order No. 18-UI-121824, dismissing claimant's request for hearing. On January 16, 2019, Order No. 18-UI-121824 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 27, 2019, claimant filed a late application for review with the EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On February 27, 2019, the appellant filed an application for review of Order No. 18-UI-121824 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than January 16, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must show good cause for the late filing, the application for review must be filed within a 7-day reasonable time period, and include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070.

With his application for review, claimant included a cover letter addressed to "Lori" in which he stated, "I apologize for this being late. I know this will be considered 'not timely,'" and submitted two pages showing copies of emails he exchanged with an attorney. Although claimant's statement acknowledged the late filing, he provided no explanation as to why the application was filed after the filing deadline expired. As such, he has not shown good cause, has not shown that his late application for review was

filed within the 7-day reasonable time period, and has not included a written statement describing the circumstances that prevented a timely filing. Accordingly, the application for review is dismissed.

Order No. 18-UI-121824 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed February 27, 2019 is dismissed. Order No. 18-UI-121824 remains undisturbed.
