

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0232**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On December 13, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 72241). Claimant filed a timely request for hearing. On January 28, 2019, ALJ Wymer conducted a hearing, and on January 29, 2019 issued Order No. 19-UI-123598, affirming the Department's decision. On February 19, 2019, Order No. 19-UI-123598 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 5, 2019, claimant filed a late application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 19-UI-123598 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. OAR 471-041-0070(1) (March 20, 2014). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing OAR 471-040-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0050(2)(b).

Claimant filed his application for review of Order No. 19-UI-123598 two weeks late. In his application for review, claimant implied that it was late because he did not receive Order No. 19-UI-123598 in the mail. However, claimant did not state when he otherwise became aware of the Order. Absent that information, we cannot find that claimant's alleged failure to receive Order No. 19-UI-123598 in the mail prevented him from filing a timely application for review. Nor could we find that claimant filed his application for review within a reasonable time, seven days, after he otherwise became aware of Order No. 19-UI-123598. Claimant's late application for review therefore is dismissed.

**DECISION:** The application for review filed March 5, 2019 is dismissed. Order No. 19-UI-123598 remains undisturbed.
